Pacific Drilling S.A. (PACD) has announced a 1-for-10 reverse stock split. As a result of the reverse stock split, each PACD Common Share will be converted into the right to receive 0.10 (New) Pacific Drilling S.A. (PACD) Common Shares. The reverse stock split will become effective at the market open on May 25, 2016.
