On July 28, 2015, Shareholders of Pall Corporation (PLL) voted concerning the proposed merger with Pentagon Merger Sub, Inc., a wholly-owned subsidiary of Danaher Corporation. The merger was approved and subsequently consummated before the open on August 31, 2015. As a result, each existing PLL Common Share will be converted into the right to receive \$127.20 net cash per share.

CONTRACT ADJUSTMENT

NEW DELIVERABLE
PER CONTRACT: \$12,720.00 Cash (\$127.20 x 100)

Settlement in PLL options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

ACCELERATION OF EXPIRATIONS

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Pall Corporation options whose expiration dates are after 9-18-2015 will have their expiration dates advanced to 9-18-2015. Expiration dates occurring before 9-18-2015 (e.g., Flex options) will remain unchanged.

All Pall Corporation options will utilize a \$.01 exercise threshold.

Option Symbol: PLL
Existing Expiration: All months
New expiration date: 9-18-2015

Existing American-style Pall Corporation options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in three business days.
