Peregrine Pharmaceuticals, Inc. (PPHM) has announced a 1-for-7 reverse stock split. As a result of the reverse stock split, each PPHM Common Share will be converted into the right to receive approximately 0.142857 (New) Peregrine Pharmaceuticals, Inc. Common Shares. Fractional PPHM shares will be rounded up to the next whole share. The reverse stock split will become effective before the market open on July 10, 2017.
