## SUBJECT: POLYPORE INTERNATIONAL, INC. – CASH SETTLEMENT/ACCELERATION OF EXPIRATIONS OPTION SYMBOL: PPO DATE: 8/26/15

On May 12, 2015, Shareholders of Polypore International, Inc. (PPO) voted concerning the proposed merger with ESM Holdings Corporation, a wholly-owned subsidiary of Asahi Kasei Corporation. The merger was approved and subsequently consummated before the open on August 26, 2015. As a result, each existing PPO Common Share will be converted into the right to receive \$60.50 net cash per share.

### CONTRACT ADJUSTMENT

Settlement in PPO options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

## ACCELERATION OF EXPIRATIONS

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Polypore International, Inc. options whose expiration dates are after 9-18-2015 will have their expiration dates advanced to 9-18-2015. Expiration dates occurring before 9-18-2015 (e.g., Flex options) will remain unchanged.

All Polypore International, Inc. options will utilize a \$.01 exercise threshold.

Option Symbol: PPO Existing Expiration: All months New expiration date: 9-18-2015

Existing American-style Polypore International, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in three business days.
