**SUBJECT:** PARTNERRE LTD. –CASH SETTLEMENT/ACCELERATION OF EXPIRATIONS

On November 19, 2015, Shareholders of PartnerRe Ltd. (PRE) voted concerning the proposed merger with Pillar Ltd., a wholly-owned subsidiary of Exor N.V. The merger was approved and subsequently consummated before the opening of business on March 18, 2016. As a result, each existing PRE Common Share will be converted into the right to receive the merger consideration of \$137.50 net cash per share.

Additionally, for each share of PRE common stock held at the time of the merger's completion, shareholders will receive a special dividend of \$3.00 cash.

#### **CONTRACT ADJUSTMENT**

NEW DELIVERABLE  
PER CONTRACT: \$14,050.00 Cash ((\$137.50 merger consideration + \$3.00 special dividend) x 100)

Settlement in PRE options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

#### **ACCELERATION OF EXPIRATIONS**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of PartnerRe Ltd. options whose expiration dates are after 4-15-2016 will have their expiration dates advanced to 4-15-2016. Expiration dates occurring before 4-15-2016 (e.g., Flex options) will remain unchanged.

All PartnerRe Ltd. options will utilize a \$.01 exercise threshold.

Option Symbol: PRE  
Existing Expiration: All months  
New expiration date: 4-15-2016

Existing American-style PartnerRe Ltd. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in three business days.
