ParkerVision, Inc. (PRKR) has announced a 1-for-10 reverse stock split. As a result of the reverse stock split, each PRKR Common Share will be converted into the right to receive 0.10 (New) ParkerVision, Inc. Common Shares. The reverse stock split will become effective at the market open on March 30, 2016.
