On September 15, 2017, Shareholders of PAREXEL International Corporation (PRXL) voted concerning the proposed merger with a subsidiary of West Street Parent, LLC, affiliated with Pamplona Capital Management LLP. The merger was approved and subsequently consummated on September 29, 2017. As a result, each existing PRXL Common Share will be converted into the right to receive \$88.10 net cash per share.

CONTRACT ADJUSTMENT

PER CONTRACT: \$8,810.00 Cash (\$88.10 x 100)

Settlement in PRXL options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

ACCELERATION OF EXPIRATIONS

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of PAREXEL International Corporation options whose expiration dates are after 10-20-2017 will have their expiration dates advanced to 10-20-2017. Expiration dates occurring before 10-20-2017 (e.g., Flex options) will remain unchanged.

All PAREXEL International Corporation options will utilize a \$.01 exercise threshold.

New expiration date: 10-20-2017

Existing American-style PAREXEL International Corporation options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
