On July 25, 2018, Shareholders of Quality Care Properties, Inc. (QCP) voted concerning the proposed merger with Potomac Acquisition LLC, a wholly owned subsidiary of Welltower Inc. The merger was approved and subsequently consummated on July 26, 2018. As a result, each existing QCP Common Share will be converted into the right to receive \$20.75 net cash per share.

**CONTRACT ADJUSTMENT**

NEW DELIVERABLE  
PER CONTRACT: \$2,075.00 Cash (\$20.75 x 100)

Settlement in QCP options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

**ACCELERATION OF EXPIRATIONS**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Quality Care Properties, Inc. options whose expiration dates are after 8-17-2018 will have their expiration dates advanced to 8-17-2018. Expiration dates occurring before 8-17-2018 (e.g., Flex options) will remain unchanged.

All Quality Care Properties, Inc. options will utilize a \$.01 exercise threshold.

Option Symbol: QCP  
Existing Expiration: All months  
New expiration date: 8-17-2018

Existing American-style Quality Care Properties, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
