ProShares UltraShort QQQ ETF (QID) has announced a 1-for-4 reverse stock split. As a result of the reverse stock split, each QID Share will be converted into the right to receive 0.25 (New) ProShares UltraShort QQQ ETF (QID) Shares. The reverse stock split will become effective at the market open on January 24, 2014.
