The Options Clearing Corporation (OCC) has been informed that Quality Systems, Inc. (QSII) will change its name, trading symbol and CUSIP to NextGen Healthcare, Inc. (NXGN), CUSIP 65343C102. As a result, option symbol QSII will also change to NXGN effective at the opening of business on September 10, 2018.

Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbol NXGN commencing September 10, 2018.
