On September 13, 2017, Shareholders of Bankrate, Inc. (RATE) voted concerning the proposed merger with Baton Merger Corp., a wholly-owned subsidiary of Red Ventures Holdco, LP. The merger was approved and subsequently consummated on November 8, 2017. As a result, each existing RATE Common Share will be converted into the right to receive \$14.00 net cash per share.

**CONTRACT ADJUSTMENT**

NEW DELIVERABLE  
PER CONTRACT: \$1,400.00 Cash (\$14.00 x 100)

Settlement in RATE options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

**ACCELERATION OF EXPIRATIONS**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Bankrate, Inc. options whose expiration dates are after 11-17-2017 will have their expiration dates advanced to 11-17-2017. Expiration dates occurring before 11-17-2017 (e.g., Flex options) will remain unchanged.

All Bankrate, Inc. options will utilize a \$.01 exercise threshold.

Existing Expiration: All months  
New expiration date: 11-17-2017

Existing American-style Bankrate, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
