On August 24, 2015, Strix Corporation, a wholly-owned subsidiary of Celgene Corporation, completed its tender offer for Receptos, Inc. (RCPT) Common Shares. The subsequent merger was completed on August 27, 2015. As a result, each existing RCPT Common Share will be converted into the right to receive \$232.00 net cash per share.

CONTRACT ADJUSTMENT

DATE: August 28, 2015

NEW DELIVERABLE PER CONTRACT: \$23,200.00 (\$232.00 x 100)

Settlement in RCPT options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

ACCELERATION OF EXPIRATIONS

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Receptos, Inc. options whose expiration dates are after 9-18-2015 will have their expiration dates advanced to 9-18-2015. Expiration dates occurring before 9-18-2015 (e.g., Flex options) will remain unchanged.

All Receptos, Inc. options will utilize a \$.01 exercise threshold.

Option Symbol: RCPT
Existing Expiration: All months
New expiration date: 9-18-2015

Existing American-style Receptos, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in three business days.
