Royal Dutch Shell plc has announced a simplification of its company share structure by establishing a single line of shares, thus eliminating Shell's A/B share structure. As a result, the Royal Dutch Shell plc Class A (RDSA) American Depositary Shares will begin trading under the name, trading symbol, and CUSIP of Shell plc (SHEL), CUSIP 780259305 effective January 31, 2022. Option symbols RDSA/2RDSA will also change to SHEL/2SHEL effective at the opening of business on January 31, 2022.

Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbols SHEL/2SHEL commencing January 31, 2022.
