VanEck Vectors Rare Earth/Strategic Metals ETF (REMX) has announced a 1-for-3 reverse stock split. As a result of the reverse stock split, each REMX share will be converted into the right to receive approximately 0.333333 (New) VanEck Vectors Rare Earth/Strategic Metals ETF share. The reverse stock split will become effective before the market open on April 15, 2020. Cash will be paid in lieu of fractional REMX shares.

DELAYED SETTLEMENT

The REMX component of the REMX1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the REMX1 deliverable until the cash in lieu of

fractional REMX Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
