The Options Clearing Corporation (OCC) has been advised that Radioshack Corporation (RSH) will change its trading symbol to RSHC, effective February 3, 2015, due to the listing of the company on an OTC market. As a result, option symbol RSH will change to RSHC effective at the opening of business on **February 4, 2015**.

Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbol RSHC commencing February 4, 2015.
