On March 22, 2017 R Aquisition Sub, Inc., a wholly owned subsidiary of Harland Clarke Holding Corporation, completed its tender offer for RetailMeNot, Inc. (SALE) Series 1 Common Shares. The subsequent merger was completed before the open on May 23, 2017. As a result, each existing SALE Common Share will be converted into the right to receive \$11.60 net cash per share.

## **CONTRACT ADJUSTMENT**

PER CONTRACT: \$1,160.00 Cash (\$11.60 x 100)

Settlement in SALE options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

## **ACCELERATION OF EXPIRATIONS**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of RetailMeNot, Inc. options whose expiration dates are after 6-16-2017 will have their expiration dates advanced to 6-16-2017. Expiration dates occurring before 6-16-2017 (e.g., Flex options) will remain unchanged.

All RetailMeNot, Inc. options will utilize a \$.01 exercise threshold.

Option Symbol: SALE

Existing Expiration: All months New expiration date: 6-16-2017

Existing American-style RetailMeNot, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in three business days.
