The Options Clearing Corporation (OCC) has been informed that Select Comfort Corporation (SCSS) will change its name, trading symbol and CUSIP to Sleep Number Corporation (SNBR), CUSIP 83125X103. As a result, option symbol SCSS will also change to SNBR effective at the opening of business on November 1, 2017.

Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbol SNBR commencing November 1, 2017.
