On November 7, 2016, Shareholders of SunEdison Semiconductor Limited (SEMI) voted concerning the proposed Scheme of Arrangement with GWafers Singapore Pte. Ltd., a wholly-owned subsidiary of GlobalWafers Co., Ltd. The merger was approved and subsequently consummated before the open on December 2, 2016. As a result, each existing SEMI Common Share will be converted into the right to receive \$12.00 net cash per share.

CONTRACT ADJUSTMENT

Settlement in SEMI options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

ACCELERATION OF EXPIRATIONS

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of SunEdison Semiconductor Limited options whose expiration dates are after 12-16-2016 will have their expiration dates advanced to 12-16-2016. Expiration dates occurring before 12-16-2016 (e.g., Flex options) will remain unchanged.

All SunEdison Semiconductor Limited options will utilize a \$.01 exercise threshold.

Existing American-style SunEdison Semiconductor Limited options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in three business days.
