The Options Clearing Corporation (OCC) has been informed that SFX Entertainment, Inc. (SFXE) will change its trading symbol to SFXEQ, due to the listing of the company on an OTC market. As a result, option symbol SFXE will also change to SFXEQ effective at the opening of business on February 10, 2016.

Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbol SFXEQ commencing February 10, 2016.
