SUBJECT: A. SCHULMAN, INC. – CASH SETTLEMENT/ACCELERATION OF

EXPIRATIONS

On June 14, 2018, Shareholders of A. Schulman, Inc. (SHLM) voted concerning the proposed merger with LYB Americas Holdco Inc., a wholly owned subsidiary of LyondellBasell Industries N.V. The merger was approved and subsequently consummated before the open on August 21, 2018. As a result, each existing SHLM Common Share will be converted into the right to receive \$42.00 net cash per share plus one non-transferrable Contingent Value Right (CVR).

NOTE: The Contingent Value Rights represent a non-transferrable contractual right to receive additional payments, if any, as described in the SHLM Proxy Statement dated May 11, 2018. **SHLM options will NOT be adjusted to call for the delivery of the CVRs.**

CONTRACT ADJUSTMENT

DATE: August 21, 2018

NEW DELIVERABLE

PER CONTRACT: \$4,200.00 Cash (\$42.00 x 100)

Settlement in SHLM options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

ACCELERATION OF EXPIRATIONS

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of A. Schulman, Inc. options whose expiration dates are after 9-21-2018 will have their expiration dates advanced to 9-21-2018. Expiration dates occurring before 9-21-2018 (e.g., Flex options) will remain unchanged.

All A. Schulman, Inc. options will utilize a \$.01 exercise threshold.

Option Symbol: SHLM

Existing Expiration: All months New expiration date: 9-21-2018

Existing American-style A. Schulman, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
