## SUBJECT: SHORETEL, INC. - CASH SETTLEMENT/ACCELERATION OF EXPIRATIONS OPTION SYMBOL: SHOR DATE: 9/25/17

On September 22, 2017 Shelby Acquisition Corporation, a wholly owned subsidiary of Mitel US Holdings, Inc, completed its tender offer for ShoreTel, Inc. (SHOR) Common Shares. The subsequent merger was completed before the open on September 25, 2017. As a result, each existing SHOR Common Share will be converted into the right to receive \$7.50 net cash per share.

### **CONTRACT ADJUSTMENT**

NEW DELIVERABLEPER CONTRACT:\$750.00 Cash (\$7.50 x 100)

Settlement in SHOR options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

### **ACCELERATION OF EXPIRATIONS**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of ShoreTel, Inc. options whose expiration dates are after 10-20-2017 will have their expiration dates advanced to 10-20-2017. Expiration dates occurring before 10-20-2017 (e.g., Flex options) will remain unchanged.

All ShoreTel, Inc. options will utilize a \$.01 exercise threshold.

Option Symbol: SHOR Existing Expiration: All months New expiration date: 10-20-2017

Existing American-style ShoreTel, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
