ProShares Short S&P 500 (SH) has announced a 1-for-2 reverse stock split. As a result of the reverse stock split, each SH Share will be converted into the right to receive 0.50 (New) ProShares Short S&P 500 (SH) Shares. The reverse stock split will become effective at the market open on June 24, 2016.
