On May 20, 2021, Shareholders of Shaw Communications Inc. (SJR) voted concerning the proposed plan of arrangement with Rogers Communications Inc. The plan of arrangement was approved and subsequently consummated on April 3, 2023. As a result, each existing SJR Class B Non-Voting Participating Share will be converted into the right to receive 40.50 CAD net cash per share.

Contract Adjustment

Date: April 4, 2023

New Deliverable Per Contract: 100 x the USD equivalent of 40.50 CAD

Settlement: OCC will delay settlement of SJR deliverable until the final net cash merger consideration is confirmed. Once the final amount is determined, settlement in SJR options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.
