SL Green Realty Corporation (SLG) has announced a 1-for-1.03060 reverse stock split. As a result of the reverse stock split, each SLG Common Share will be converted into the right to receive approximately 0.97030856 (New) SL Green Realty Corporation Common Shares. The reverse stock split will become effective before the market open on January 24, 2022. Cash will be paid in lieu of fractional SLG shares.

**Pricing**

Until the cash in lieu amount is determined, the underlying price for SLG4 will be determined as follows:

$$\text{SLG4} = 0.97030856 (\text{SLG})$$

**Delayed Settlement**

The SLG component of the SLG4 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the SLG4 deliverable until the cash in lieu of fractional SLG Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
