Sonder Holdings Inc. (SOND) has announced a 1-for-20 reverse stock split. As a result of the reverse stock split, each SOND Class A Common Share will be converted into the right to receive 0.05 (New) Sonder Holdings Inc. Class A Common Shares. The reverse stock split will become effective before the market open on September 21, 2023.
