Direxion Daily S&P 500 Bear 3X Shares (SPXS) has announced a 1-for-10 reverse stock split. As a result of the reverse stock split, each SPXS share will be converted into the right to receive 0.10 (New) Direxion Daily S&P 500 Bear 3X Shares. The reverse stock split will become effective before the market open on January 11, 2021.
