ProShares UltraPro Short S&P500 ETF (SPXU) has announced a 1-for-4 reverse stock split. As a result of the reverse stock split, each SPXU Share will be converted into the right to receive 0.25 (New) ProShares UltraPro Short S&P500 ETF (SPXU) Shares. The reverse stock split will become effective at the market open on January 24, 2014.
