The Options Clearing Corporation (OCC) has been informed that SunEdison, Inc. (SUNE) will change its trading symbol to SUNEQ, due to the listing of the company on an OTC market. As a result, option symbol SUNE will also change to SUNEQ effective at the opening of business on April 22, 2016.

Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbol SUNEQ commencing April 22, 2016.
