SUPERVALU INC. (SVU) has announced a 1-for-7 reverse stock split. As a result of the reverse stock split, each SVU Common Share will be converted into the right to receive approximately 0.142857 (New) SUPERVALU INC. Common Shares. The reverse stock split will become effective before the market open on August 2, 2017. Cash will be paid in lieu of fractional SVU shares.

DELAYED SETTLEMENT

The SVU component of the SVU1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the SVU1 deliverable until the cash in lieu of fractional SVU shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
