The Options Clearing Corporation (OCC) has been informed that Smith & Wesson Holding Corporation (SWHC) will change its name, trading symbol and CUSIP to American Outdoor Brands Corporation (AOBC), CUSIP 02874P103. As a result, option symbol SWHC will also change to AOBC effective at the opening of business on January 3, 2017.

Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbol AOBC commencing January 3, 2017.
