## SUBJECT: TECO ENERGY, INC. – CASH SETTLEMENT/ACCELERATION OF EXPIRATIONS OPTION SYMBOL: TE DATE: 7/1/16

On December 3, 2015, Shareholders of TECO Energy, Inc. (TE) voted concerning the proposed merger with Emera US Inc., a wholly-owned subsidiary of Emera Inc. The merger was approved and subsequently consummated before the open on July 1, 2016. As a result, each existing TE Common Share will be converted into the right to receive \$27.55 net cash per share.

### **CONTRACT ADJUSTMENT**

DATE: July 1, 2016

NEW DELIVERABLEPER CONTRACT:\$2,755.00 Cash (\$27.55 x 100)

Settlement in TE options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

### **ACCELERATION OF EXPIRATIONS**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

TECO Energy, Inc. options whose expiration dates are after 7-15-2016 will have their expiration dates advanced to 7-15-2016. Expiration dates occurring before 7-15-2016 (e.g., Flex options) will remain unchanged.

TECO Energy, Inc. options will utilize a \$.01 exercise threshold. Option Symbol: TE Existing Expiration: All months New expiration date: 7-15-2016

Existing American-style TECO Energy, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in three business days.
