On October 7, 2015, Shareholders of Thoratec Corporation (THOR) voted concerning the proposed merger with Spyder Merger Corporation, a wholly-owned subsidiary of St. Jude Medical, Inc. The merger was approved and subsequently consummated on October 8, 2015. As a result, each existing THOR Common Share will be converted into the right to receive \$63.50 net cash per share.

**CONTRACT ADJUSTMENT**

NEW DELIVERABLE  
PER CONTRACT: \$6,350.00 Cash (\$63.50 x 100)

Settlement in THOR options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

**ACCELERATION OF EXPIRATIONS**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Thoratec Corporation options whose expiration dates are after 10-16-2015 will have their expiration dates advanced to 10-16-2015. Expiration dates occurring before 10-16-2015 (e.g., Flex options) will remain unchanged.

All Thoratec Corporation options will utilize a \$.01 exercise threshold.

Option Symbol: THOR  
Existing Expiration: All months  
New expiration date: 10-16-2015

Existing American-style Thoratec Corporation options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in three business days.
