The Options Clearing Corporation (OCC) has been advised that Tekmira Pharmaceuticals Corporation (TKMR) will change its name, trading symbol and CUSIP to Arbutus Biopharma Corporation (ABUS), CUSIP 03879J100. As a result, option symbols TKMR/2TKMR will also change to ABUS/2ABUS effective at the opening of business on August 3, 2015.

Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbols ABUS/2ABUS commencing August 3, 2015.
