ProShares UltraShort Russell2000 ETF (TWM) has announced a 1-for-4 reverse stock split. As a result of the reverse stock split, each TWM Share will be converted into the right to receive 0.25 (New) ProShares UltraShort Russell2000 ETF (TWM) Shares. The reverse stock split will become effective at the market open on January 24, 2014.
