On June 9, 2016, a subsidiary of OC Acquisition LLC, which is a wholly-owned subsidiary of Oracle Corporation, completed its tender offer for Textura Corporation (TXTR) Common Shares. The subsequent merger was completed on June 10, 2016. As a result, each existing TXTR Common Share will be converted into the right to receive \$26.00 net cash per share.

**CONTRACT ADJUSTMENT**

**NEW DELIVERABLE  
PER CONTRACT:** \$2,600.00 (\$26.00 x 100)

Settlement in TXTR options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

**ACCELERATION OF EXPIRATIONS**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Textura Corporation options whose expiration dates are after 6-17-2016 will have their expiration dates advanced to 6-17-2016. Expiration dates occurring before 6-17-2016 (e.g., Flex options) will remain unchanged.

All Textura Corporation options will utilize a \$.01 exercise threshold.

Existing Expiration: All months  
New expiration date: 6-17-2016

Existing American-style Textura Corporation options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in three business days.
