Direxion Daily Small Cap Bear 3X Shares (TZA) has announced a 1-for-8 reverse stock split. As a result of the reverse stock split, each TZA share will be converted into the right to receive 0.125 (New) Direxion Daily Small Cap Bear 3X Shares. The reverse stock split will become effective before the market open on March 2, 2021. Cash will be paid in lieu of fractional TZA shares.

OCC will delay settlement of the cash portion of the TZA1 deliverable until the cash in lieu of fractional TZA Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
