Unilife Corporation (UNIS) has announced a 1-for-10 reverse stock split. As a result of the reverse stock split, each UNIS Common Share will be converted into the right to receive 0.10 (New) Unilife Corporation (UNIS) Common Shares. The reverse stock split will become effective at the market open on May 13, 2016.
