2x Long VIX Futures ETF (UVIX) has announced a 1-for-10 reverse stock split. As a result of the reverse stock split, each UVIX share will be converted into the right to receive 0.10 (New) UVIX ETF Shares. The reverse stock split will become effective before the market open on October 11, 2023.
