The Options Clearing Corporation (OCC) has been advised that Walgreen Co. (WAG) will change its name, trading symbol and CUSIP to Walgreens Boots Alliance, Inc. (WBA), CUSIP 931427108. As a result, option symbols WAG/1WAG/2WAG will also change to WBA/1WBA/2WBA effective at the opening of business on December 31, 2014.

Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbol WBA/1WBA/2WBA commencing December 31, 2014.
