Whiting Petroleum Corporation (WLL) has announced a 1-for-4 reverse stock split. As a result of the reverse stock split, each WLL Common Share will be converted into the right to receive 0.25 (New) Whiting Petroleum Corporation Common Shares. The reverse stock split will become effective before the market open on November 9, 2017.
