On October 4, 2016, Shareholders of The WhiteWave Foods Company (WWAV) voted concerning the proposed merger with July Merger Sub Inc., a wholly-owned subsidiary of Danone S.A.. The merger was approved and subsequently consummated before the open on April 12, 2017. As a result, each existing WWAV Common Share will be converted into the right to receive \$56.25 net cash per share.

## **CONTRACT ADJUSTMENT**

DATE: April 12, 2017

NEW DELIVERABLE

PER CONTRACT: \$5,625.00 Cash (\$56.25 x 100)

Settlement in WWAV options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

## **ACCELERATION OF EXPIRATIONS**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of The WhiteWave Foods Company options whose expiration dates are after 4-21-2017 will have their expiration dates advanced to 4-21-2017. Expiration dates occurring before 4-21-2017 (e.g., Flex options) will remain unchanged.

All The WhiteWave Foods Company options will utilize a \$.01 exercise threshold.

Option Symbol: WWAV

Existing Expiration: All months New expiration date: 4-21-2017

Existing American-style The WhiteWave Foods Company options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in three business days.
