SUBJECT: WUXI PHARMATECH (CAYMAN) INC. – CASH SETTLEMENT OPTION SYMBOL: WX DATE: 12/11/15

On November 25, 2015, Shareholders of WuXi PharmaTech (Cayman) Inc. (WX) voted concerning the proposed merger with WuXi Merger Limited, a wholly-owned subsidiary of New WuXi Life Science Limited. The merger was approved and subsequently consummated on December 10, 2015. As a result, each existing WX American Depositary Share will be converted into the right to receive \$45.95 (\$46.00 less \$0.05 ADR fee) net cash per share, less withholdings, if any.

CONTRACT ADJUSTMENT

NEW DELIVERABLE PER CONTRACT:	\$4,595.00 Cash (\$45.95 x 100), less withholdings, if any
SETTLEMENT:	OCC will delay settlement of the WX deliverable until the final net cash merger consideration is confirmed. Once the final amount is determined, settlement in WX options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

ACCELERATION OF EXPIRATIONS

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series (See OCC Information Memo 23988).
