On March 14, 2016, Shareholders of Youku Tudou Inc. (YOKU) voted concerning the proposed merger with Ali YK Subsidiary Holding Limited, a wholly-owned subsidiary of Ali YK Investment Holding Limited. The merger was approved and subsequently consummated on April 5, 2016. As a result, each existing YOKU American Depositary Share will be converted into the right to receive \$27.60 net cash per share, less fees and withholdings, if any. Each YOKU ADS may be subject to an ADS cancellation fee of up to \$0.05 per ADS.

## **CONTRACT ADJUSTMENT**

**NEW DELIVERABLE** 

PER CONTRACT: \$2,760.00 Cash (\$27.60 x 100), less fees and withholdings, if any

SETTLEMENT: OCC will delay settlement of the YOKU deliverable until the final net merger

consideration is confirmed. Once the final amount is determined, settlement in YOKU options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the

extended strike amount and the cash deliverable.

## **ACCELERATION OF EXPIRATIONS**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to **an acceleration of the expiration dates for outstanding option series** (See OCC Information Memo 23988).
