Zogenix, Inc. (ZGNX) has announced a 1-for-8 reverse stock split. As a result of the reverse stock split, each ZGNX Common Share will be converted into the right to receive 0.125 (New) Zogenix, Inc. Common Shares. The reverse stock split will become effective before the market open on July 1, 2015.

PRICING

Until the cash in lieu amount is determined, the underlying price for ZGNX1 will be determined as follows:

$$\text{ZGNX1} = 0.125 (\text{ZGNX})$$

DELAYED SETTLEMENT

The ZGNX component of the ZGNX1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the ZGNX1 deliverable until the cash in lieu of fractional ZGNX Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
