RE: Consolidated Audit Trail ("CAT") Clock Synchronization Study

The CAT NMS Plan requires the exchanges and FINRA to prepare a written assessment of current clock synchronization standards to assess whether any changes to those standards would be appropriate. To assist in this assessment, the exchanges and FINRA have prepared a short study to collect information regarding current clock synchronization practices from broker-dealers, exchanges and FINRA, as well as third-party vendors or similar providers. MIAX Options requests that MIAX Option Members have the appropriate individual who is familiar with its Business Clock Synchronization practices complete the CAT Clock Synchronization Study and submit their responses no later than 5pm (ET) on Friday, April 21, 2017.
