RE: Name Change and Change to the Market for Underlying Security Used for Openings on MIAX

Options, MIAX Pearl Options and MIAX Emerald Options for Symbol CREE (WOLF) Effective

Monday, October 4, 2021

Cree, Inc. ("CREE") will have a name and symbol change to Wolfspeed, Inc. (WOLF) effective on Monday, October 4, 2021 and will transfer primary listing from the NASDAQ Global Select Market to the New York Stock Exchange ("NYSE") effective Monday, October 4, 2021. As set forth in MIAX Options Rule 503(d), MIAX Pearl Rule 503(a)(3) and MIAX Emerald Rule 503(d), the exchanges shall use NYSE as the "market for the underlying security" for the purpose of Openings on the Exchange.
