PARTIAL AMENDMENT

Miami International Securities Exchange LLC (“MIAX” or “Exchange”) is filing this Partial Amendment No. 1 to SR-MIAX-2014-56 to make the following changes to clarify that ISE does not guarantee price improvement over the NBBO today.

- P. 8, of the Purpose Section in the 19b-4, the Exchange proposes to remove the following language including the language in footnote 10:

“ISE’s PIM mechanism has no size differentiation and only guarantees price improvement over the ISE NBBO.¹⁰”

- P. 20, to the Purpose Section in Exhibit 1, the Exchange also proposes to make the corresponding changes as necessary.
